Introduction

This document describes how to use and service the U3045AM04 Multiport Extension Test Set with the Agilent 4-Port PNA or PNA-X Network Analyzer for an 8-Port solution.

Description

The Agilent U3045AM04 is a Multiport Test Set that adds 4 ports to extend the 4-Port network analyzer to

8 full crossbar test ports with N-Port calibration capability.

The Agilent U3045AM04 has the following key features:

- 4 test ports (2.4 mm male connectors)
- · Low Loss Mechanical RF switching
- Frequency Range of Operation: 10 MHz 50 GHz
- Test Set I/O interface for operational control with the network analyzer. Option 551 is required for N-port calibration. An external personal computer is not required.
- A standard Agilent System II instrument cabinet (4EIA height x 497.8 mm depth)

The N5244/5A PNA-X network analyzer will be referred to throughout this document as the PNA-X. The U3045AM04 will be referred to as the test set.

Verifying the Shipment

To verify the contents shipped with your product, refer to the "Box Content List" included with the shipment.

Inspect the shipping container. If the container or packing material is damaged, it should be kept until the contents of the shipment have been checked mechanically and electrically. If there is physical damage refer to "Contacting Agilent" on page 75. Keep the damaged shipping materials (if any) for inspection by the carrier and an Agilent Technologies representative.

Network Analyzer Requirements

All network analyzers require Option 551 for multiport operation (N-Port error correction and measurement capability). Table 1 provides a listing of other network analyzer option requirements. The network analyzer's frequency range must be equal to or exceed that of the test set so that the measurement system covers the full frequency range of the test set.

The test set files indicated in Table 1 must be installed into the analyzer's file directory: c:\Program Files\Agilent\Network Analyzer\testsets

General Specifications

Specifications for the test set are characteristic for the system performance of the network analyzer and the test set. Before using the network analyzer and test set a calibration is recommended for best measurement performance. Actual performance of the system is based on the customer's network analyzer and options that are used with the test set. A functional certificate is only offered for the test set.

When connected to a network analyzer, this test set will degrade the performance at the test ports. The internal switch paths reduce test port power and power to the receivers. This affects the test port power of the network analyzer and also reduces dynamic range. The reflection tracking values measured in the "Operational Check with Cal Kit" on page 44 can be subtracted from the analyzers dynamic range to determine the approximate performance of the system.

CAUTION	The life expectancy of the following switches are 5 million cycles. When making
	measurements using more than one port, single sweeps are recommended to
	minimize switch cycles.

Power Requirements

Verify that the required ac power is available before installing the test set to the network analyzer.

- 100/120/220/240 VAC (50/60Hz)
- The instruments can operate with mains supply voltage fluctuations up to ± 10% of the nominal voltage.
- Air conditioning equipment (or other motor–operated equipment) should not be placed on the same ac line that powers the test set and network analyzer.
- N5244A and N5245A maximum power is 450 W.
- U3045AM04 maximum power is 350 W.

WARNING This is a Safety Class I Product (provided with a protective earthing ground incorporated in the power cord). The mains plug shall be only be inserted in a socket outlet provided with a protective earth contact. Any interruption of the protective conductor inside or outside of the product is likely to make the product dangerous. Intentional interruption is prohibited.

Environmental Requirements

Refer to the PNA series standard documentation for environmental requirements.

Environmental Tests

The test set complies with all applicable safety and regulatory requirements for the intended location of use.

- Temperature 0 50 °C
- Pressure Altitude 3,000 meters (~10,000 feet)
- The instrument can safely operate in a relative humidity of 80% for temperatures to 31 degrees C, decreasing linearly to 50% relative humidity at 40 degrees C.

Equipment Heating and Cooling

If necessary, install air conditioning and heating to maintain the ambient temperature within the appropriate range.

CAUTION Ventilation Requirements: When installing the instrument in a cabinet, the convection into and out of the instrument must not be restricted. The ambient temperature (outside the cabinet) must be less than the maximum operating temperature of the instrument by 4 °C for every 100 watts dissipated in the cabinet. If the total power dissipated in the cabinet is greater than 800 watts, forced convection must be used.

Required Conditions for Accuracy Enhanced Measurement

Accuracy enhanced (error–corrected) measurements require the ambient temperature of the network analyzer and test set to be maintained within \pm 1 °C of the ambient temperature at calibration.

Dimensions and Space Requirements

Standard installation of the test set and network analyzer includes configuration and installation on a customer provided lab bench or table top of adequate size and strength. For weight, dimensions and space requirements, refer to the network analyzer documentation that is used to configure the test set.

CAUTION	The network analyzer is heavy. It is recommended that two individuals, or a
	mechanical lift be used to lift or transport the instrument.

Test Port's LEDs

An illuminated LED indicates an active port in Source or Receiver mode. On the front panel "S" indicates Source test ports and "R" indicates Receiver test ports.

Standby Switch


Note that this switch is Standby only, not a line switch. The main power cord can be used as the system disconnecting device. It disconnects the mains circuits from the mains supply.

Active LED

The Active LED is on when the test set is connected and addressed by a network analyzer. The LED is off when the test set is in Standby, or not addressed by the network analyzer.

Chassis Ground

A threaded terminal post for connecting the test set to a conductive object, cabinet or structure to ensure a common potential and reduce leakage current in a system. Requires an English 1/4-20 thread nut (2950-0004) and lock washer (2190-0067).

Pass Through Interface

The Pass Through Interface is used to connection to another test set.

Test Set Interface

The test set Interface connector is used to send address and data to the test set from the network analyzer.

Line Module

The line fuse, as well as a spare, reside within the line module. Figure 4 illustrates where the fuses are located and how to access them.

Install the instrument so that the detachable power cord is readily identifiable and is easily reached by the operator. The detachable power cord is the instrument disconnecting device. It disconnects the mains circuits from the mains supply before other parts of the instrument. The front panel switch is only a standby switch and is not a LINE switch. Alternatively, an externally installed switch or circuit breaker (which is readily identifiable and is easily reached by the operator) may be used as a disconnecting device.

CAUTION Always use the three-prong ac power cord supplied with this product. Failure to ensure adequate grounding by not using this cord may cause damage to the product.

Power Cords

A line power cord is supplied in one of several configurations, depending on the destination of the original shipment. Agilent can supply additional certified power cords to meet region electrical supply and receptacle configurations. Please contact Agilent at: www.agilent.com for assistance in power cord selection.

WARNING The detachable power cord is the instrument disconnecting device. It disconnects the mains circuits from the mains supply before other parts of the instrument. The front panel switch is only a standby switch and is not a LINE switch (disconnecting device).

Hardware Lock-link Installation (U3021-60002)


If your system is to be rack mounted, this installation procedure does not have to be performed.

WARNING The opening of covers or removal of parts is likely to expose dangerous voltages. Disconnect the instrument from all voltage sources while it is being opened.

Locking the Test Set to the Network Analyzer


- 1. The lock-link kit (U3021-60002) includes:
 - 5023-0132 Lock-links kit (left, right pair and screws), analyzer
 - 0515-2317 Screw T15 M3.5 x 0.6 12 mm
 - N5242-20138 Right Lock-link, test set
 - N5242-20139 Left Lock-link, test set
- 2. Remove the feet from the bottom of the analyzer.
- 3. Remove the 2 lower standoffs from the rear panel on the analyzer using a T20 torx driver.

4. Install the lower left and right lock-links (left not shown) onto the analyzer, as shown in Figure 6.

Figure 6 Install Lock-links to the Network Analyzer




- 5. Remove the two upper standoffs from the rear panel of the test set using a T20 torx driver.
- 6. Install the left and right lock-links onto the test set, as shown in Figure 7.

7. Place the analyzer on top of the test set and ensure that the front frame of the analyzer is positioned slightly forward of the locks that are attached to the test set. Slide the analyzer back so the locks engage the front frame of the analyzer.

8. Secure the analyzer's lower lock-links to the test set's upper lock-link using the spring–loaded screws. If the analyzer's lock-links are not aligned with the screw holes, loosen the screws securing the feet to the instrument to align and tighten.

Figure 10 illustrates the cable configuration of the test set to the network analyzer. The cables have been supplied with Cable Kit (U3021-60089).

- 1. Remove the SOURCE OUT to CPLR THRU and RCVR IN to CPLR ARM jumpers (x8) on the network analyzer. The RCVR R1 to SOURCE OUT reference loop jumpers (x4) remain on the front panel. Keep the jumpers for future use.
- 2. Connect the RF interconnect cables from the network analyzer to the test set in the order listed. As you are connecting each cable, torque to 8 in-lb. Refer to Table 6 and Figure 10.

CAUTION Over torque will cause damage to the test set and may cause connectors to spin or become loose.

Test Set I/O Cable Installation

1. Connect the test set I/O cable (N4011-21002) to the test set Interface connector on the rear panel, similar to Figure 11.

Interconnect Cable Verification

- 1. Perform the "System Operational Check" on page 18.
- 2. If the problem still exists, perform the "RF Switching Failures" on page 59.
- 3. If a power hole or other failure still exists, refer to "Contacting Agilent" on page 75.

System Operational Check

The following procedure will confirm that the RF interface cables between the Test Set and analyzer are installed and the system is working correctly.

Before beginning this procedure you should complete the following steps:

- Stack the analyzer on top of the Test Set.
- Install the Test Set interface cable on the rear panel.
- Install all of the RF interface cables on the front panel.
- Install the included female 2.4 mm short (85056-60021) to analyzer's Port 1.
- Ensure that the connectors are clean.

Equipment Setup

- Turn On the Test Set and analyzer.
- Preset the analyzer and make the following settings:
 - Set to Multi-Port Mode (see Multiport Mode Operation (on page 22)
 - Frequency range: 10 MHz to 50 GHz
 - IFBW: 1 kHz
 - Scale: 20 dB/Div
 - Set the analyzer to measure S11

Check Results

The 2.4 mm short will be moved to each test port and the trace on the analyzer is set to measure the S-parameter of each port. An uncorrected Sxx reflection response trace should be displayed and resemble the plots indicated in the Table 7 on page 18. If you suspect an RF signal path problem, refer to the RF cable diagram and check the interface cables associated with the signal path for proper installation.

NOTE Some trace amplitude ripple is expected on the reflection response due to the use of a short as a test device. Use an ECal to verify reflection tracking.




Figure 12Typical Reflection Response Ports 1-4

Figure 13 Reflection Response Signal Path Diagram Ports 1-4




Figure 14 Typical Reflection Response Ports 5-8





Figure 15 Reflection Response Signal Path Diagram Ports 5-8



Controlling the U3045AM04

This section will describe how to operate the Test Set with the analyzer.

A analyzer must be used to control the Test Set using the Test Set I/O interface on the rear panel. There are three methods to control the Test Set. Multiport mode is recommended due to ease of use and multiport calibration capability (N-Port).

- "Interface Control Mode" on page 29.
- "GPIB Control Mode" on page 33.

Typeface Key Conventions

The following key conventions are used throughout this document.

- [HARDKEYS] are labeled front panel keys
- · SOFTKEYS are indicated on the instrument display

Sweep Setup for Multiport and Standalone Modes

Due to the extra electrical length of the test set and test port cables, it is recommended that the analyzer's Sweep Setup be configured to Stepped Sweep before calibrating. This is slower than the Analog Sweep, but is more accurate. Stepped Sweep is available on all models.

- 1. On the analyzer select **STIMULAS** > **Sweep** > **Sweep** Setup.
- 2. Select Stepped Sweep.
- 3. Set the **Dwell Time to 5 ms > OK**.

Multiport Mode

The analyzer requires Option 551 for Multiport mode. The analyzer must have the Test Set file installed to enable the analyzer to control the Test Set. The analyzer multiport mode allows you to select measurement ports, complete an N-Port calibration, operate control lines, and rename test ports. Refer to the Help menu for more information.

Multiport Mode Operation

- 1. The Option 551 must be installed for multiport capability. To access the multiport application select **Utility > System > Configure > Multiport Capability**.
- Select U3045AM04_PNAX_p4 (8-Port System) from the drop-down menu and select Restart as a multiport PNA with this testset > OK. The analyzer will restart the network application with the Test Set interface features.

If the Test Set is not available in the drop-down list, it will be necessary for you to copy the required Test Set file to the analyzer hard drive. The current version of the Test Set files are available on the web at http://na.tm.agilent.com/multiport. Copy the appropriate file to c:\program files\Agilent\Network Analyzer\testsets directory.




Figure 17 Selecting Multiport Mode

External Test Set Control Operation

To verify that the network application has the Test Set interface features, select **Trace/Chan > Channel > Hardware Setup > External Test Set > Other**. The Test Set will be displayed as **External Test Set Control-U3045AM04**.




Figure 18 External Test Set Control


This menu will allow the physical Ports 1 thru 8 to be identified as any port for your convenience. For example; Port 5 can be re-named Port 2.

The **External Test Set Control-U3045AM04** also allows control of the DUT control lines, refer to "Control Lines" on page 38. To change the state from LOW to HIGH, select the graphical user interface (GUI) for the specific control (LINE 1 thru 8), click OK. Each line can be controlled separately.

Selecting S-Parameter Measurement

S-Parameter selection can be accomplished using **Response** > **Measure**. Use the drop-down menu to select 1 of 64 S-Parameters for the 8-Port system. The first number in the Sxx selection is the Receiver Port and the second number will be the Source Port. Any port can be selected to be the Receiver, Source or both, as in S11. The front panel R LED indicates the port is the Receiver and the S LED indicates the port is the Source.


Figure 19 S-Parameter Measurement

N-Port Calibration with the Analyzer


It is recommended that you perform an ECal characterization to minimize the connections required for multiple port calibration. The N4693A Option M0F is recommended with cable (85133F) if you are calibrating at the analyzer and Test Set ports.

Characterize the ECal module with adapters that will not be used in the measurement of the DUT. To characterize the ECal module select **Response** > **Cal** > **ECal** > **Characterize ECal Module**.

Calibrate at the end of the test port RF cables and any adapters that are used to connect the DUT. This removes the effect on the measurement of the DUT. Failure to do this will create ripple and other measurement errors.





Enable Interface Control: (1)

Enables and disables ALL Interface Control communication. When cleared (default setting) Interface Control is disabled and NO data is sent. To send data, the individual interfaces must also be enabled.

Test Set I/O Control (addr.data): (2)

Provides control of the Test Set I/O Interface on the rear panel of the analyzer. Used to control your Test Set.

Only positive integers are allowed to select switch positions or states of DUT control interface lines. Refer to "Address and Data Values" on page 36.

Address and data integers must be separated by a period. Each set of entries should be separated by a new line, or carriage return. The front panel Enter key can be used to insert a new line into the field. The quantity of Test Set I/O entries that can be entered is limited by the available memory of the analyzer.

Channel: (4)

Specifies the channel number for dialog settings. Each channel is configured individually. The drop-down list illustrates the channels that currently have measurements. There must be at least one displayed trace for the Test Set I/O Interface to function.

Channel Control Label: (5)

Specifies the label to be displayed on the analyzer's screen during the channel sweep.

Before Sweep Start – After Sweep End Tabs: (6)

Commands (GPIB, I/O's and Dwell) can be sent Before Sweep Start and After Sweep End. However, they are configured and enabled separately on the Interface Control dialog box. For example; to send a command before and after an analyzer sweep, the Enable Interface Control check box must be selected and commands entered in both the Before Sweep Start and After Sweep End tabs. The **Before Sweep Start** data is sent before the first trace on the channel begins sweeping. The **After Sweep Start** data is sent after the last trace on the channel sweep is completed.

Dwell After Command: (7)

Reset All:

Sets all fields on all channels to their default values.

Save and Recall:

Saves and recalls the contents of the dialog box. If the Interface Control dialog box is populated with settings during an Instrument State Save, the settings are automatically recalled with the instrument state settings. Interface control uses an *.xml file type. An example file is stored on the analyzer's hard drive. You can recall it into the dialog, or you can open and edit it with a word processor, such as Word Pad.

OK:







Address and Data Values

Setting the Test Port Paths with Address and Data




Figure 31 Address and Data Example 1 (Port 5 and 6)

Refer to Table 8 and Figure 31 on page 37 for information to set the internal switch paths of the Test Set.

The address is the first value in the Test Set I/O control or GPIB data command. The second value controls the source and receiver paths of the ports. To select a Test Set port configuration both switches must be set to complete the source and receiver paths. To do this you must add the data values together to determine the data command value for each port, which is the second number in the Test Set I/O or GPIB command. Refer to "Interface Control Mode" on page 29 and in "GPIB Control Mode" on page 33.

Example 1: Refer to Figure 31 on page 37.

If the ports have different addresses, two separate address data commands must be used.

Port 5 is the Source and Port 6 is the Receiver.

Source Port 5 = address 0, data 1 and Receiver Port 6 = address 16, data 16. Two separate commands must to be sent, you may use the same dialog box. The entry will be 0.1 in one command line, and 16.16 in the second line.

Example 2:

If the ports have the same address, only one command is needed.

Port 1 is the Source and Ports 5 is the Receiver.

Source Port 1 = address 0, data 0 and Receiver Port 5 = address 0, data 16. The data values are added together, the entry will be 0.16.

Control Lines

The 15 pin female D-Sub connector on the rear panel provides 8 latched data lines that can be used to control your device under test (DUT). The lines can be controlled with the multiport external test set control, or Test Set I/O commands. Refer to "External Test Set Control Operation" on page 23 and "Setting the Control Lines with Address and Data Values" on page 42. See Table 9 for DUT control line specification.




Figure 32 DUT Control Line Pin Assignment (rear panel view)

The output voltage of the lines can be from the internal adjustable voltage source (+2 to +5 Vdc), or an external dc power supply depending on how the connection to the control line is configured. When using an external power supply a positive or negative voltage can be used. Refer to Figure 32 and Table 10 on page 39 for control line pin location and description. Refer to "Internal Voltage Supply Configuration" on page 40 and "External Voltage Supply Configuration" on page 41 for configurations.









After a power reset all DUT control lines are initially configured to a logic high state or connected to Pin 13, refer to Figure 33 on page 40. To reset all control lines to logic high, without having to reset the power switch on the Test Set, make the following analyzer entry:

Front panel analyzer Interface Control Mode line entry = 112.0 > OK.

Always determine which control lines you want set to a logic zero, the other remaining lines will automatically be set to a logic high. Note the <data> value of these lines and calculate the SUM of their <data> values.

Listed are two examples to illustrate this concept. Refer to Figure 28, shown with all lines = logic high.

Example 1: To change lines 1 & 8 to equal logic Low, all others logic high.

- 1. Line 1 (<address> = 112 and <data> = 1)
- 2. Line 8 (<address> = 112 and <data> = 128)
- 3. The SUM of the <data> values = 129
- 4. Front panel analyzer Interface Control Mode line entry = 112.129 > OK.

Example 2: From Example 1 to only change Lines 2 & 3 to equal logic low, all others logic high.

- 1. Line 2 (<address> = 112 and <data> = 2)
- 2. Line 3 (<address> = 112 and <data> = 4)
- 3. The SUM of the <data> values = 6
- 4. Front panel analyzer Interface Control Mode line entry = 112.6 > OK.

NOTE Since all control lines have the same <address>, only one "<address>.<data>" command line is needed to control all 8 lines.

Operational Check with Cal Kit

The following procedure can be used to confirm 1-Port Cal performance of an ECal Module or Mechanical Cal Kit. The operation verification limits provided ensure that your U3045AM04 and analyzer are operating properly. Refer to "Verifying a Cal Kit Operational Check Failure" on page 49 to ensure the RF interface cables are installed and working correctly before returning the Test Set for repairs.

Verification Limits

Specifications for the Test Set are typical. System performance for the analyzer and Test Set are only characteristic and intended as non-warranted information. Only a functional certificate is provided for the Test Set.

It is recommended that you return your instrument to Agilent Technologies for servicing or repair if the Test Set and analyzer performance exceed the operational verification limits.

A periodic calibration is not required. The Operators Check should be performed after System Setup, or if performance is in question. An N-Port calibration should be performed before making a measurement. Refer to Table 4 on page 8.

NOTE	If you suspect that your 8-Port configuration is not operating properly, ensure that
	all front RF jumper interconnect cables are correctly attached.

Operational Check Procedure

The sequence of this procedure is very important and must be followed or the performance accuracy and results may vary from the reference plots provided. Ensure that the Test Set is not connected to the analyzer if you are performing a analyzer Operational Check. The analyzer will indicate false failures if the Test Set is connected.

Preparing the Analyzer

- 1. Connect the Test Set to the 4-Port analyzer using the interconnect cables as shown in Figure 10 on page 16 and Table 6 on page 16.
- 2. Turn On the Test Set.
- On the analyzer, select Response> Cal > Manage Cals > Cal Set. Delete or Rename any Cal Sets titled "999.1" thru "999.8" (8-Port), although it is unlikely that you will find Cal Sets with these names.
- 4. Verify that the analyzer is in 8-Port mode. See the bottom of the measurement window.
 - a. If only four S-Parameters are listed, select Utility > System > Configure > Multiport Capability. Select Restart as multiport PNA with this testset and select U3045AM04 (8-Port) from the drop-down menu > OK. Refer to Figure 17 on page 22.
- 5. Press Preset.
- 6. Verify that the [Start Frequency] is set to [10 MHz].
- 7. Set [Stop Frequency] to [50 GHz], or upper frequency limit for your analyzer.
- 8. Select [Power] > Power Level and enter [0 dBm].
- 9. Select Response > Avg > IF Bandwidth > 100 Hz > OK.
- 10.Select Stimulus > Sweep > Number of Points > 401.
- 11.Connect the ECal module to an available USB port on the front or rear panel. This procedure assumes you are using a ECal. If you are not, see "1-Port Calibration and Verification Procedure" on page 46, step 2.
- 12.Allow the ECal module, Test Set and Analyzer to warm up for a minimum of 30 minutes.




Figure 37 Calibration, Cal Set Viewer

Figure 38 Reflection Tracking Trace (Port 1-4)





Figure 39 Reflection Tracking Trace (Port 5-8)



NOTE Response from 10 MHz to 500 MHz is normal due to the analyzer's couplers in comparison to the Test Set bridges. The bridges have more gain in the coupled RF path.

Verifying a Cal Kit Operational Check Failure

If your test results fail the Cal Kit Operational Check Reflection Tracking limits, verify the following:

- 1. Ensure the Test Set is On and connected properly to the analyzer.
- 2. Check all appropriate analyzer and Test Set connectors for damage, cleanliness, and proper torques.
- 3. Repeat the relevant 1-Port calibrations using another ECal or mechanical standard.
- 4. Verify that the analyzer is operating properly and meeting its published specifications. If the analyzer is connected to the Test Set it will fail the Operational Check. Refer to "Network Analyzer Requirements" on page 4.

ECal Confidence Check

The following procedure is a method to verify the accuracy of a 1-Port calibration performed with mechanical standards or an ECal module. To perform this check, the test port of the ECal module must connect directly to the Test Port being verified (without adapters).

Procedure

- 1. Perform an 1-Port Cal of the Test Set port being verified.
- 2. Connect the ECal Module to the Port being verified. Terminate any remaining ports on the ECal module.



Figure 41 U3045AM04 RF Block Diagram






Figure 42 U3045AM04 Electrical Diagram

Theory of Operation

The following is a description of the operation of the Test Set. Reference the Test Set block diagrams shown in Figure 41 on page 52 and Figure 42 on page 53. This section assumes the user has a general understanding of couplers, switches, and network analyzers.

The Test Set adds four test ports to a 4-Port network analyzer. The internal RF switches direct the source output and receiver input to the selected port coupler.

The switches and couplers are arranged in four groups to control the source and receiver paths of the analyzer port to the couplers in the column under the analyzer port.

RF Coupler

The Test Set uses four couplers (5087-7724) on the front panel for RF Test Ports 5 - 8. The couplers provide the signal separation of the source and receiver paths. The Test Set ports can receive from or stimulate a signal to the DUT.

The RF Test Port connectors are male 2.4 mm. The coupling factor is approximately -18 dB for the Coupled Arm for frequencies > 1 GHz to 50 GHz (approximately -53 dB < 1 GHz). The insertion loss through the CPLR THRU path is typically < 4 dB at 50 GHz.

RF Switch Components

The Test Set uses eight mechanical switches (N1811-60023) that have internal 50 Ω termination and a external 50 Ω termination (00901-60003). The switches select the RF paths from the analyzer source and receiver through interconnect cables to the Test Set.

Source and Receiver Switch Paths

SW10 - Source to Ports (1 and 5) Switch 10 provides control of the Source Output path to analyzer Port 1 and Test Set Port 5. In the state shown in the block diagram, switch 10 routes the RF Source back to the analyzer Port 1, and Test Set Source path to Port 5 is terminated.

SW20 - Source to Ports (3 and 6) Switch 20 provides control of the Source Output path to analyzer Port 3 and Test Set Port 6. In the state shown in the block diagram, switch 20 routes the RF Source back to the analyzer Port 3, and Test Set Source path to Port 6 is terminated.

SW30 - Source to Ports (4 and 7) Switch 30 provides control of the Source Output path to analyzer Port 4 and Test Set Port 7. In the state shown in the block diagram, switch 30 routes the RF Source back to the analyzer Port 4, and Test Set Source path to Port 7 is terminated.

SW40 - Source to Ports (2 and 8) Switch 40 provides control of the Source Output path to analyzer Port 2 and Test Set Port 8. In the state shown in the block diagram, switch 40 routes the RF Source back to the analyzer Port 2, and Test Set Source path to Port 8 is terminated.

SW13 - Receiver to Ports (1 and 5) Switch 13 provides control of the Receiver Input path to analyzer Port 1 and Test Set Port 5. In the state shown in the block diagram, switch 13 routes Port 1 Coupler Arm to the Receiver, and Test Set Port 5 Coupler Arm path is terminated.

SW23 - Receiver to Ports (3 and 6) Switch 23 provides control of the Receiver Input path to analyzer Port 3 and Test Set Port 6. In the state shown in the block diagram, switch 23 routes Port 3 Coupler Arm to the Receiver, and Test Set Port 6 Coupler Arm path is terminated.

SW33- Receiver to Ports (4 and 7) Switch 33 provides control of the Receiver Input path to analyzer Port 4 and Test Set Port 7. In the state shown in the block diagram, switch 33 routes Port 4 Coupler Arm to the Receiver, and Test Set Port 7 Coupler Arm path is terminated.

SW43 - Receiver to Ports (2 and 8) Switch 43 provides control of the Receiver Input path to analyzer Port 2 and Test Set Port 8. In the state shown in the block diagram, switch 43 routes Port 2 Coupler Arm to the Receiver, and Test Set Port 8 Coupler Arm path is terminated.

Non-RF Failures

Typical malfunctions may be the rear panel fan, control lines or front panel indicator lights.

- 1. Verify that the front panel Power Switch is operational.
 - a. The rear panel fan and front panel Active LED should operate when the Standby Switch is in the On position.
- 2. AC line voltage checks (remove AC power from the instrument).
 - a. Ensure the proper AC line voltage is present at the instrument line cord.
 - b. Remove the AC power cord from the instrument. Confirm the instrument AC line module fuse is operational. See Figure 4 on page 12.
 - c. Internal AC line fuses Remove the bottom cover of the instrument. Near the rear panel are two fuse holders, remove the fuses and verify that they are operational. Refer to Figure 49 on page 67.


WARNING The opening of covers or removal of parts is likely to expose the user to dangerous voltages. Disconnect the instrument from all voltage sources before being opened.

- 3. Internal DC Power During this check you will apply AC power to the instrument with the top cover removed. Connect the AC power cord to the test set.
 - a. Set the front panel switch to the Standby position. The fans and indicator lights should be Off.
 - b. Set the standby switch to the On position. The rear panel and internal power supply fans should be operational. The Active LED will be On when test set is connected to an active network analyzer and is addressed by the network analyzer
 - c. Verify that the DC LEDs indicators are On.
 Note: The LEDs only indicate the presence of a DC voltage, not the DC voltage level.


Figure 43 DC Power Status LEDs

 Use the indicated wire locations for voltage measurements, TP1 is your common. Refer to Figure 43 on page 57.

- d. If there is no DC power, suspect the power supply module. The actual power supply terminal connection should also be confirmed with a DVM by removing the bottom cover and using the power supply label to identify the terminal voltage values.
- e. If all of the DC Input LEDs are On and the fan is not working, replace fan.

NOTE The +9 and –10 Vdc indicators are not used in this instrument (Off is normal).

- 4. Front panel R and S indicator LED check.
 - a. If the indicators are not operating, continue to "RF Switching Failures" step 1 and step 2.

- 5. Control Lines are not working.
 - a. Verify that the control voltage pin connections to the DUT control lines are connected properly. Refer to "Control Lines" on page 38.
 - b. Verify that the rear panel DC voltage control adjustment can be set to 5 Vdc. Refer to Figure 3 on page 11.
 - c. Remove the instrument top cover. Using a DVM, verify that the three DC voltage inputs are present on the DUT control board (E5091-66503). Refer to Figure 44.
 - d. If the DC voltages are normal, then replace the DUT control board. If the voltages are not present, check the ribbon cable and its connections at both ends. Suspect the test set Control board as the possible problem.

RF Switching Failures

Typical failures may be the loss of RF switch control failure or a non RF failure as outlined in the prior section. The internal RF switches used in this instrument are controlled by the +24 Vdc from the Switch Driver board.

- 1. Confirm that the network analyzer and test set are properly connected using the test set I/O cable (N4011-21002). See Figure 11 on page 17.
- 2. Using Multiport Mode (Option 551), verify that the network analyzer firmware is correct, and that the test set file is loaded into the network analyzer. Refer to "Network Analyzer Requirements" on page 4.
- 3. Using the I/O command values, confirm that the correct address and data values are used. Refer to "Address and Data Values" on page 36.
- 4. Follow the "Non-RF Failures" on page 56 procedure (if not already done so).
- 5. Front Panel R and S indicator LED Check.
 - a. Confirm that the test set Controller Board Status LED's are On. Refer to Figure 43 on page 57. If the LED's are Off remove the Switch Driver board, if the LED's are remain Off replace the Controller board.
 - b. If the Status LED's are On and the front panel Active LED is On, suspect the front panel LED board or the ribbon cable (replace as needed).
- Confirm the DC +24 Vdc switch drive voltages on the Switch Driver Bd by connecting a voltmeter to one of the Jxx locations as shown in Figure 44 on page 58. Do not disconnect the RF Switch connector, this will keep the switch in place as a load for the following voltage measurement.




Figure 45 Switch Drive Voltage Check

Test Set RF Switching Path

If you suspect an RF signal path problem with the test set and have verified that the problem is not the front panel RF interface cables, the following procedure will check all of the RF signal paths through the test set.

- Install the test set I/O Interface cable from the network analyzer to the test set rear panel.
- Remove the front panel test set to network analyzer RF interface cables and reinstall the network analyzer front panel jumper cables.







RF Performance Failures

If the U3045AM04 operates correctly, but RF performance fails the operational test. The following procedures can be used to isolate the failed component. Suspect the coax switches (N1811-60023), RF cables, or coupler (5087-7793).

- NOTE The RF performance of the U3045AM04 depends on the performance of the network analyzer. Ensure the network analyzer is meeting specification before continuing.
- 1. Verify that the test set and network analyzer SOURCE, RCVR, CPLR THRU, and CPLR ARM connectors are clean and that the center pins are not damaged.
- 2. Verify the interface and internal RF cables are cleaned and not damaged. "Verifying a Cal Kit Operational Check Failure" on page 49.
- 3. Review the "Operational Check with Cal Kit" on page 44 and verify the results for the port that is failing.
- 4. Reflection tracking trace shows a power hole, or is below the test limit line, perform the switch path test for the port that is failing.
- 5. Directivity trace fails (above -10dB), replace the couplers (5087-7793).
- 6. Source or load match fails (above -10 dB), replace the coax switch (N1811-60023).
- 7. Isolation is poor between ports, inspect the RF connections. If it continues to fail replace the coax switch (N1811-60023). The RF cables require proper torque (10 in-lb) and can be damaged by over tightening.

Figure 49 Test Set Top View





Figure 50 Test Set Bottom View



 - 1. Connect a short to one end of the cable to short the center conductor to the outer conductor.
 - 2. While wearing a grounded wrist strap, grasp the outer shell of the cable connector.
 - 3. Connect the other end of the cable to the test port and remove the short from the cable.
