WARRANTY

Hardware

Keithley Instruments, Inc. warrants that, for a period of one (1) year from the date of shipment (3 years for Models 2000, 2001, 2002, 2010 and 2700), the Keithley Hardware product will be free from defects in materials or workmanship. This warranty will be honored provided the defect has not been caused by use of the Keithley Hardware not in accordance with the instructions for the product. This warranty shall be null and void upon: (1) any modification of Keithley Hardware that is made by other than Keithley and not approved in writing by Keithley or (2) operation of the Keithley Hardware outside of the environmental specifications therefore.

Upon receiving notification of a defect in the Keithley Hardware during the warranty period, Keithley will, at its option, either repair or replace such Keithley Hardware. During the first ninety days of the warranty period, Keithley will, at its option, supply the necessary on site labor to return the product to the condition prior to the notification of a defect. Failure to notify Keithley of a defect during the warranty shall relieve Keithley of its obligations and liabilities under this warranty.

Other Hardware

The portion of the product that is not manufactured by Keithley (Other Hardware) shall not be covered by this warranty, and Keithley shall have no duty of obligation to enforce any manufacturers' warranties on behalf of the customer. On those other manufacturers' products that Keithley purchases for resale, Keithley shall have no duty of obligation to enforce any manufacturers' warranties on behalf of the customer.

Software

Keithley warrants that for a period of one (1) year from date of shipment, the Keithley produced portion of the software or firmware (Keithley Software) will conform in all material respects with the published specifications provided such Keithley Software is used on the product for which it is intended and otherwise in accordance with the instructions therefore. Keithley does not warrant that operation of the Keithley Software will be uninterrupted or error-free and/or that the Keithley Software will be adequate for the customer's intended application and/or use. This warranty shall be null and void upon any modification of the Keithley Software that is made by other than Keithley and not approved in writing by Keithley.

If Keithley receives notification of a Keithley Software nonconformity that is covered by this warranty during the warranty period, Keithley will review the conditions described in such notice. Such notice must state the published specification(s) to which the Keithley Software fails to conform and the manner in which the Keithley Software fails to conform to such published specification(s) with sufficient specificity to permit Keithley to correct such nonconformity. If Keithley determines that the Keithley Software does not conform with the published specifications, Keithley will, at its option, provide either the programming services necessary to correct such nonconformity or develop a program change to bypass such nonconformity in the Keithley Software. Other Software

KEITHLEY Safety Precautions

The following safety precautions should be observed before using this product and any associated instrumentation. Although some instruments and accessories would normally be used with non-hazardous voltages, there are situations where hazardous conditions may be present.

This product is intended for use by qualified personnel who recognize shock hazards and are familiar with the safety precautions required to avoid possible injury. Read and follow all installation, operation, and maintenance information carefully before using the product. Refer to the manual for complete product specifications.

If the product is used in a manner not specified, the protection provided by the product may be impaired.

The types of product users are:

Responsible body is the individual or group responsible for the use and maintenance of equipment, for ensuring that the equipment is operated within its specifications and operating limits, and for ensuring that operators are adequately trained.

Operators use the product for its intended function. They must be trained in electrical safety procedures and proper use of the instrument. They must be protected from electric shock and contact with hazardous live circuits.

Maintenance personnel perform routine procedures on the product to keep it operating properly, for example, setting the line voltage or replacing consumable materials. Maintenance procedures are described in the manual. The procedures explicitly state if the operator may perform them. Otherwise, they should be performed only by service personnel.

Service personnel are trained to work on live circuits, and perform safe installations and repairs of products. Only properly trained service personnel may perform installation and service procedures.

Keithley products are designed for use with electrical signals that are rated Installation Category I and Installation Category II, as described in the International Electrotechnical Commission (IEC) Standard IEC 60664. Most measurement, control, and data I/O signals are Installation Category I and must not be directly connected to mains voltage or to voltage sources with high transient over-voltages. Installation Category II connections require protection for high transient over-voltages often associated with local AC mains connections. Assume all measurement, control, and data I/O connections are for connection to Category I sources unless otherwise marked or described in the Manual.

Exercise extreme caution when a shock hazard is present. Lethal voltage may be present on cable connector jacks or test fixtures. The American National Standards Institute (ANSI) states that a shock hazard exists when voltage levels greater than 30V RMS, 42.4V peak, or 60VDC are present. A good safety practice is to expect that hazardous voltage is present in any unknown circuit before measuring.

Operators of this product must be protected from electric shock at all times. The responsible body must ensure that operators are prevented access and/or insulated from every connection point. In some cases, connections must be exposed to potential human contact. Product operators in these circumstances must be trained to protect themselves from the risk of electric shock. If the circuit is capable of operating at or above 1000 volts, no conductive part of the circuit may be exposed.

Do not connect switching cards directly to unlimited power circuits. They are intended to be used with impedance limited sources. NEVER connect switching cards directly to AC mains. When connecting sources to switching cards, install protective devices to limit fault current and voltage to the card.

Before operating an instrument, make sure the line cord is connected to a properly grounded power receptacle. Inspect the connecting cables, test leads, and jumpers for possible wear, cracks, or breaks before each use.

When installing equipment where access to the main power cord is restricted, such as rack mounting, a separate main input power disconnect device must be provided, in close proximity to the equipment and within easy reach of the operator.

For maximum safety, do not touch the product, test cables, or any other instruments while power is applied to the circuit under test. ALWAYS remove power from the entire test system and discharge any capacitors before: connecting or disconnecting cables or jumpers, installing or removing switching cards, or making internal changes, such as installing or removing jumpers.

Do not touch any object that could provide a current path to the common side of the circuit under test or power line (earth) ground. Always make measurements with dry hands while standing on a dry, insulated surface capable of withstanding the voltage being measured.

The instrument and accessories must be used in accordance with its specifications and operating instructions or the safety of the equipment may be impaired.

Do not exceed the maximum signal levels of the instruments and accessories, as defined in the specifications and operating information, and as shown on the instrument or test fixture panels, or switching card.

When fuses are used in a product, replace with same type and rating for continued protection against fire hazard.

Chassis connections must only be used as shield connections for measuring circuits, NOT as safety earth ground connections.

If you are using a test fixture, keep the lid closed while power is applied to the device under test. Safe operation requires the use of a lid interlock.

If $\stackrel{\frown}{=}$ or $\stackrel{\frown}{m}$ is present, connect it to safety earth ground using the wire recommended in the user documentation.

The \(\frac{\bar{\chi}}{\chi} \) symbol on an instrument indicates that the user should refer to the operating instructions located in the manual.

The symbol on an instrument shows that it can source or measure 1000 volts or more, including the combined effect of normal and common mode voltages. Use standard safety precautions to avoid personal contact with these voltages.

The **WARNING** heading in a manual explains dangers that might result in personal injury or death. Always read the associated information very carefully before performing the indicated procedure.

The CAUTION heading in a manual explains hazards that could damage the instrument. Such damage may invalidate the warranty.

Instrumentation and accessories shall not be connected to humans.

Before performing any maintenance, disconnect the line cord and all test cables.

To maintain protection from electric shock and fire, replacement components in mains circuits, including the power transformer, test leads, and input jacks, must be purchased from Keithley Instruments. Standard fuses, with applicable national safety approvals, may be used if the rating and type are the same. Other components that are not safety related may be purchased from other suppliers as long as they are equivalent to the original component. (Note that selected parts should be purchased only through Keithley Instruments to maintain accuracy and functionality of the product.) If you are unsure about the applicability of a replacement component, call a Keithley Instruments office for information.

To clean an instrument, use a damp cloth or mild, water based cleaner. Clean the exterior of the instrument only. Do not apply cleaner directly to the instrument or allow liquids to enter or spill on the instrument. Products that consist of a circuit board with no case or chassis (e.g., data acquisition board for installation into a computer) should never require cleaning if handled according to instructions. If the board becomes contaminated and operation is affected, the board should be returned to the factory for proper cleaning/servicing.

1 Introduction

Getting started

The KPCMCIA-RS422/485S is a single-channel RS422/RS485 asynchronous serial adapter for systems equipped with PCMCIA Type II and/or Type III expansion sockets. The KPCMCIA-RS422/485S is a PCMCIA Type II (5mm) card and is PCMCIA PC card standard specification 2.1 compliant.

The KPCMCIA-RS422/485S's serial port is implemented using a 16C550 Universal Asynchronous Receiver/Transmitter (UART), which is the recommended communications interface for multitasking environments and for applications involving high data transfer rates.

The KPCMCIA-RS422/485S may be configured to operate in either the full-duplex or half-duplex mode; RTS (request to send) or DTR (data terminal ready) may be used to enable the output drivers, or the KPCMCIA-RS422/485S may be configured so the output drivers are always enabled. Another option provided in the KPCMCIA-RS422/485S is RTS-CTS modem control handshaking. This handshake may be enabled or disabled when the KPCMCIA-RS422/485S is configured. See Section 5 for more information.

2 Installation

To ease the configuration of the KPCMCIA-RS422/485S, a Windows 95 INF configuration file is included. This configuration file supports the RTS-CTS modem control handshaking option and the RS422/485 output driver enable option for full- and half-duplex operation.

Hardware installation

To physically install the KPCMCIA- RS422/485S PC card, insert the card into an available Type II KPCMCIA socket.

Software setup

Refer to your DriverLINX documentation for a detailed description of the software installation and setup procedures.

Auxiliary channel configuration


An auxiliary channel allows for handshaking between the KPCMCIA-RS422/485S port and a peripheral device. Two auxiliary channel configurations are possible:

- RTS-CTS handshaking enabled
- Handshaking disabled

Auxiliary channel: RTS-CTS handshaking enabled


Figure 3-1 **Auxiliary channel RTS-CTS handshaking**

RTS-CTS handshaking can be enabled so RTS (request to send) is the auxiliary output signal on AUX OUT+ (pin 1) and AUX OUT- (pin 6). Similarly, CTS (clear to send) is the auxiliary input signal on AUX IN+ (pin 5) and AUX IN- (pin 9). This configuration is shown in Figure 3-1.

Auxiliary channel: handshaking disabled

The KPCMCIA-RS422/485S ports can be configured so RTS-CTS handshaking is disabled, which is the default configuration. In this configuration, RTS and CTS from the 16C550 UART loop back to each other. In addition, the auxiliary output and input signals loop back to each other. This configuration is shown in Figure 3-2.

Half-duplex operation

The KPCMCIA-RS422/485S ports can be configured for either full-duplex or half-duplex operation. By default, the RS422/485 ports are configured for full-duplex operation with the RS422/485 output drivers always enabled.

In half-duplex mode, the RS422/485 transmitter can be enabled and disabled via the RTS or DTR (data terminal ready) signal. Both RTS and DTR are controlled through the modem control register of the 16C550. Refer to Figure 3-3.

3 Options: Half-Duplex RS-422/485 Driver Active Low Output Enable Full-Duplex RS-422/485 Driver Aux Out RS-422/485 Driver

NOTE: One of these three options must be selected via software configuration. Full-duplex operation is the default mode.

If RTS is selected as the signal to enable the output drivers, setting bit 1 of the modem control register (to logic 1) enables the output drivers and clearing bit 1 of the modem control register (to logic 0) forces the outputs into a high impedance state.

Similarly, if DTR is chosen as the signal to enable the output drivers, setting bit 0 of the modem control register (to logic 1) enables the output drivers and clearing bit 0 of the modem control register (to logic 0) forces the outputs into a high impedance state.

Selecting half-duplex mode depends on the configuration software and/or the operating system used. Each ultimately controls the half-duplex mode by accessing the PCMCIA configuration register on the KPCMCIA-RS422/485S.


CAUTION


When operating in half-duplex mode, disable the transmitter output drivers before they receive any information. Failure to do so will result in the two output drivers being connected together which may cause damage to the adapter, the computer, and/or the peripheral equipment.

Termination resistors

No termination resistors are provided on the KPCMCIA-RS422/485S ports. Both output and input signals are connected only to the external connector. Any termination that is required must be added externally. Refer to Figure 3-4.

4 External Connections





Figure 4-2 **RS422/485 signal assignment**

The adapter cable included with the KPCMCIA-RS422/485S converts the 9-pin PCMCIA output connector into a standard D-9 female data terminal equipment (DTE) connector, as shown in Figures 4-1 and 4-2. A male to female gender changer is provided.

Figure 4-1 **KPCMCIA-RS422/485S adapter cable**
