1. General description

The 74LVC00A-Q100 is a quad 2-input NAND gate. Inputs can be driven from either 3.3~V or 5~V devices. This feature allows the use of these devices as translators in mixed 3.3~V and 5~V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.









Fig. 7. Test circuit for measuring switching times

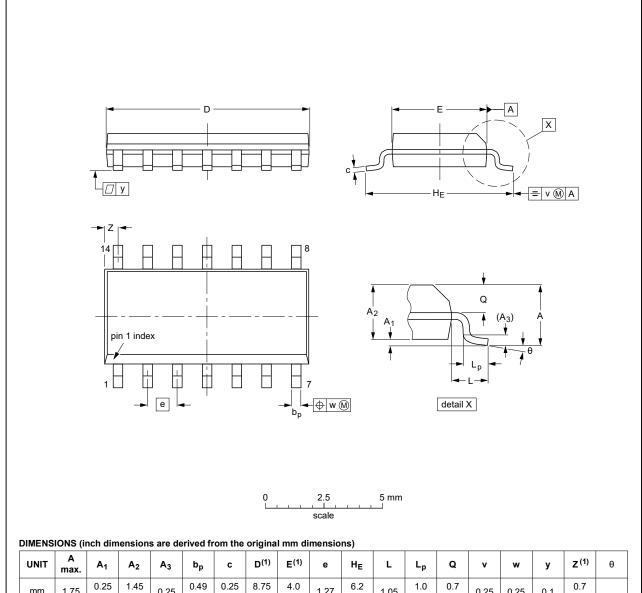



Fig. 9. Package outline SOT402-1 (TSSOP14)




Fig. 10. Package outline SOT762-1 (DHVQFN14)
