### 1. General description

The 74LVC2G17 is a dual buffer with Schmitt-trigger inputs. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments. This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.







Logic levels:  $V_{OL}$  and  $V_{OH}$  are typical output voltage levels that occur with the output load.


#### Fig. 6. The data input (nA) to output (nY) propagation delays



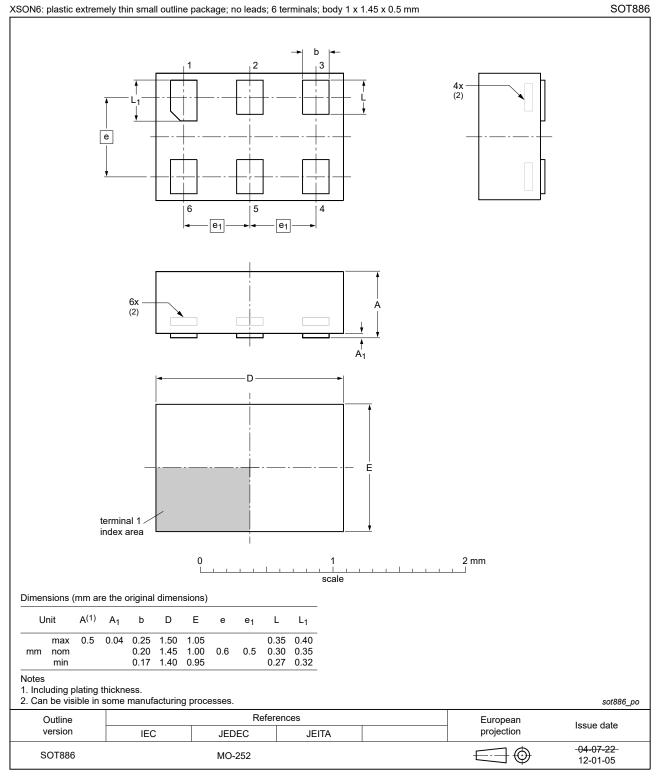


Fig. 9. Package outline SOT886 (XSON6)
